I am pleased to share with you that the Council has produced a new volume of the Newsletter 2022 which contains quite useful information about the council's current and future activities. In this regard, the council has recently published an ALERT for parents and students advising them to confirm the accreditation status of teacher education programmes prior to seeking admission. The accreditation process will not only improve the quality of teacher education but it will also help enhance professional status of teaching profession. It is our collective responsibility to improve the quality of teacher education, prepare reflective practitioners with emphasis on integration of theory to practice, and professionalize teaching for raising the quality of education in the country.

I may further share with you that HEC has formed National Curriculum Review Committee (NCRC) for reviewing teacher education roadmap and teacher education programmes. I hope the quality of teacher education programmes will be further improved in light of the recommendations of NCRC in order to meet the national and international professional standards.

Looking forward to your continued cooperation and support towards enhancing the status of teaching profession through accreditation of teacher education programmes in the country.

NATIONAL CURRICULUM REVIEW COMMITTEE (NCRC) MEETING FOR DEVELOPMENT OF TEACHER EDUCATION ROADMAP AND REVISION OF CURRICULUM

The second meeting of NCRC was organized on March 7-8, 2022 at HEC, Regional Centre, Lahore. It was in continuation of its first meeting held on July 1-2, 2021 in Peshawar. Dr. Muhammad Khalid Mahmood, Secretary of the Council participated in the first meeting of NCRC. Prof. Dr. Muhammad Memon, Chairperson of the Council and Dr. Muhammad Khalid Mahmood, Secretary of the Council participated in the second meeting in Lahore. The third meeting was held online on April 1,2022. The Chairperson and Secretary of the Council shared their perspective on the development of teacher education roadmap and curriculum, however, work is in progress.



SELECTION OF PROGRAMME MANAGER AND ADMIN/ACCOUNTS OFFICER FOR COUNCIL

A three-member selection committee held its meeting on November 11, 2021 to interview the candidates for the post of Programme Manager and Admin & Accounts Officer. The selection committee chaired by Prof. Dr Muhammad Memon, Chairperson, NACTE which selected two candidates each for the above post

GATHERING PROGRAMME DATA FROM INSTIUTIONS

The Council has gathered data regarding the programmes and pass outs from the teacher education institutions which is being compiled, however, those institutions which have not yet provided the required information are being reminded to send their information without any further delay. The Council highly appreciates efforts of the institutions for their cooperation.



MEETING WITH SECRETARIATE STAFF

Prof. Dr. Muhammad Memon, Chairperson NACTE chaired a staff meeting on November 12, 2021. The Secretary of the Council shared a report on the follow-up of the last meeting decisions. He also presented a progress on the accreditation visits. The revision of teacher education programmes was also discussed. It was also proposed to hold a meeting of the Deans, Faculty of Education from the selected universities in collaboration with Prof. Dr. Nasir Mahmood, Dean, Faculty of Education, Allama Iqbal Open University, Islamabad to review the existing teacher education roadmap and curriculum. The meeting will take place soon.

EXECUTIVE.DIRECTOR MEETING WITH CHAIRPERONS OF COUNCILS

The Executive Director, HEC convened a meeting of all Council Chairpersons on December 15, 2021 to review the councils' activities and their future plans to make the council independent and financially sustainable. Prof. Dr. Muhammad Memon, Chairperson of the Council participated in the meeting. All Council Chairpersons deliberated on the process required to make the Councils independent and financially sustainable through an Act of Parliament.

MEETING WITH HEC, ADVISOR ACADEMICS, DIRECTOR QAA, AND DEAN, FACULTY OF EDUCATION, AIOU, ISLAMABAD

The Chairperson of Council had a meeting with Mr. Raza Chohan, Advisor Academics Division, HEC on December 15, 2021 to discuss teacher education roadmap which is a matter of an urgency. The Advisor Academics informed that NCRC meeting will be convened soon and the Council Chairperson and Secretary will be invited to give their input in the NCRC meeting.

The Chairperson had a meeting with Syed Nasir Shah, Director / In-charge QAA, to discuss the Council related matters and requested funding for training of NACTE external evaluators, national conference and revision of accreditation standards, tools and procedures. The In-charge QAA assured every possible support from QAA for the proposed activities of the Council.

The Chairperson, NACTE met Prof. Dr. Nasir Mahmood, Dean, Faculty of Education, Allama Iqbal Open University, Islamabad (also a member of the Council) to discuss teacher education roadmap and a possible research study on the quality of teachers in the country. Dr. Nasir Mahmood appreciated the idea of research study on teacher quality and assured his full support to conduct the study and hold a consultation meeting with the Deans and Directors of the selected universities to discuss teacher education roadmap.



MEETING WITH SECRETARIAT STAFF

The Chairperson, NACTE had a meeting with the Secretariat staff on December 16, 2021. The Chairperson welcomed the newly appointed Programme Manager and Admin & Accounts Officer and requested them to work as a team to help grow and strengthen the Council. The

Council Secretary gave an update on the ongoing accreditation visits and shared progress on the process of accreditation data analysis, data verification and report writing. The Chairperson advised the staff to do the follow up of the activities in order to complete on time.





CONFIRM ACCREDITATION STATUS OF TEACHER EDUCATION PROGRAMMES BEFORE SEEKING ADMISSION

The National Accreditation Council for Teacher Education (NACTE) is a national organization authorized to accredit teacher education programmes. Accreditation is **mandatory** under the HEC rules for teacher education programmes offered by the public and private sector education institutions in the country.

All the public and private education institutions offering teacher education programmes are required to seek accreditation of their programmes. In case of non-accreditation of programmes, it may cause refusal to acceptance of their degree by HEC. This will not only cause embarrassment for the institutions concerned but it may further hamper future of the students.

It has also been noticed that the teacher education programmes in some universities and colleges are being initiated/offered without accreditation by the NACTE. In the larger interest of the public and the institutions, it is necessary that commencement of any new or existing teacher education programme must be made after full compliance of the NACTE prerequisites for accreditation.

Parents, particularly the students seeking admission in any teacher education programme are advised to confirm accreditation status of the programme prior to their admission.
